Na osnovu člana 148 Poslovnika Skupštine Crne Gore na **PREDLOG ZAKONA O FINANSIRANJU LOKALNE SAMOUPRAVE**, podnosim sljedeće amandmane:

A M A N D M A N 1

U članu 11 stav 1 tačka 1 mijenja se i glasi:

„1) 12% opštini koja pripada primorskom regionu, osim za opštinu čiji je stepen razvijenosti ispod 100% prosječne vrijednosti indeksa razvijenosti utvrđenog u skladu sa zakonom kojim se uređuje regionalni razvoj kojoj se ustupa 50%.“

O B R A Z L O Ž E N J E

Amandman se predlaže iz razloga ustupanja dijela prihoda od poreza na dohodak fizičkih lica, u iznosu od 50% za opštine u Primorskom regionu čiji je stepen razvijenosti ispod 100% prosječne vrijednosti indeksa razvijenosti, a što je u skladu sa odredbama Zakona o regionalnom razvoju, odnosno, razvrstavanju jedinica lokalnih samouprava po stepenu razvijenosti bez obzira kojem regionu pripadaju.

Imajući u vidu navedeno, kao i činjenicu da od primorskih opština, Opština Ulcinj je sa indeksom razvijenosti ispod 100%, neophodno je da se u skladu sa principima koji su prepoznati kroz Zakon o regionalnom razvoju, ustupi navedeni procenat prihoda od poreza na dohodak fizičkih lica.

U članu 13 poslije stava 1 dodaje se novi stav koji glasi:

„Opštini se ustupa 50% prihoda od naknade za korišćenje morskog dobra ostvarenog na teritoriji te opštine.“

U stavu 2 alineja 3 riječi: „osim morskog dobra“ brišu se.
Dosadašnji st. 2 i 3 postaju st. 3 i 4.
